Executive Order No. 2019-28

RELATIVE TO ESTABLISHING THE ZERO WASTE GUAM WORKING GROUP

WHEREAS, Zero Waste is recognized as one of the quickest, most cost-effective policies to build resiliency in communities and combat the negative impacts of climate change; and

WHEREAS, Zero Waste is the conservation of all resources by means of responsible production, consumption, reuse, and recovery of products, packaging, and materials without burning and with no discharges to land, water, or air that threaten the environment or human health; and

WHEREAS, Zero Waste can be linked to sustainable agriculture, permaculture, sustainable energy as well as sustainable industrial, economic and community development; and

WHEREAS, there is a clear connection between waste reduction, recycling, resource recovery, and beneficial reuse and the need to change unsustainable consumption, disposal, and production patterns; and

WHEREAS, the placement of materials in landfills increases greenhouse gases, wastes natural resources, and transfers liabilities to future generations; and

WHEREAS, over one hundred thousand of tons of materials are generated in Guam each year by residents, businesses, organizations, and institutions, and approximately 85% of this amount is sent to the landfill disposal; and

WHEREAS, the construction of the Layon Municipal Solid Waste Landfill Cell 3 is estimated to cost taxpayers 30 million dollars for an expected life of 10 years. The life span of the landfill can be extended only with effective implementation of waste reduction, recycling, resource recovery, and beneficial reuse programs such as those incorporated in a Zero Waste Strategy; and

WHEREAS, Zero Waste is a community-based model that aims to eliminate or minimize landfill disposal by the application of simple solutions and sustainable materials management systems that are healthy for our people, and our island; and

WHEREAS, establishing the Recycling Revolving Fund, and the Recycling Enterprise Zones at the Port Authority of Guam, were visionary policy achievements, at the time, that paved the way towards the eventual establishing a Zero Waste community for Guam; and

WHEREAS, The Association of State and Territorial Solid Waste Management Officials (ASTSMWO) has endorsed developing a Zero Waste Strategy as a significant component in implementing a comprehensive (waste) materials management program for small island communities like Guam through both regulatory and cooperative environmental governance; and

WHEREAS, waste prevention, reuse, recycling, and composting are material management options that conserve resources, and grow resilience while reducing environmental impacts and; and

WHEREAS, increased recycling saves energy, water, natural resources, reduces air and water pollution, reduces the damage caused by extracting resources from the environment, and reduces the need for landfill facilities; and

WHEREAS, it is estimated that a resource recovery-based economy will sustain, on a perton basis, up to ten times more jobs than landfilling, and these jobs will be more productive and meaningful; and

WHEREAS, recognizing that voluntary recycling goals have not, and in all probability, cannot achieve effective and efficient waste elimination; and

WHEREAS, a Zero Waste strategy presents our community with a great opportunity to protect the environment, save money for taxpayers, create new jobs and business opportunities, and advance the cause of creating a more sustainable community.

NOW THEREFORE, I, LOURDES AFLAGUE LEON GUERRERO, I Maga'hågan Guåhan, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, and the laws of Guam, do order as follows:

Creation of the Zero Waste Guam Working Group. The Zero Waste Guam Working Group is and hereby created and tasked with the following mission, purposes, and operational parameters:

- 1. Mission Statement. It is the purpose and objective of the Zero Waste Working Group to have the responsibility for developing, making recommendations for the adoption of and then overseeing all aspects of implementation of the Guam Zero Waste Master Plan including developing the outreach and public education components required to raise public awareness, to share knowledge and transfer information to the community and to the broader pacific; and
- 2. The Zero Waste Guam Working Group shall be Chaired by Finé'nena na Ásaguan Maga'hågan Guåhan, the First Gentleman, and shall include the following members:
 - a. Administrator of the Guam Environmental Protection Authority;
 - b. Director of Statistics and Plans;
 - c. General Manager of the Port Authority of Guam;
 - d. Director of Public Works; and

e. The Administrator of the Air and Land Division of the Guam Environmental Protection Agency who shall serve as Executive Director of the Working Group.
